The Public Prosecutor of Siena at the end of October decided that the request of investigation I filed on April 2015 has to be closed because there is no evidence of crime.

In the opposition that I submitted on Nov. 4th (enclosed) I stated that the District Attorney's Office missed the chance to collaborate with American Institutions about this case.

Let's keep in mind that on May 2015 all the documentation was also sent to the Department of Justice (no reply), and after my Bank of America's account was unilaterally closed on October 2015, more documentation on December 2015 was sent to the Securities and Exchange Commission (no reply): sounds odd that among the banks that are/were supposed to take over Monte dei Paschi, there is also BoA. The European Central Bank wants a recapitalization before Dec. 31st; the European Commission, according to 'Corriere della Sera' (Dec. 2nd), last summer outlined a bail-out plan; President Elect Donald Trump, not only won't be acting as an obliging clerk toward Janet Yellen, but he has also vowed to dismantle the Dodd-Frank Act. In conclusion, a Troubled Asset Relief Program now is probably the only way out, but the Siena puzzle will remain unsolved without US collaboration. Instead of a good book, many others would like to curl up with a good bank: where did all the money go?
